CM Revanth Reddy pushes for education overhaul

(Capital Information) Hyderabad, Sep 17 : Telangana Chief Minister A Revanth Reddy today reviewed the state's education policy at the Secretariat, stressing the need for radical reforms to align Telangana's education system with international standards and make it a tool for poverty eradi-

Highlighting the challenges, the Chief Minister noted that approximately 1.10 lakh engineering graduates pass out in the state every year, but only about 15% of them secure jobs. This stark disparity reflects significant gaps in employability and skills.

He also pointed out that of the Rs 21,000 crore allocated annually to the Education Department, 98 per cent is spent on salaries, leaving little for infrastructure or reforms.

Revanth Reddy noted that 34 lakh students are studving in 11,000 private schools, while 18 lakh students are enrolled in 27,000 government schools, youth," he said.



underlining disparities in quality. He said education should not just be about literacy but also about social transformation and economic empowerment.

"Education is the only way to eradicate poverty. My goal is to give a better future to 73 lakh

The Chief Minister called for a comprehensive new education policy for Telangana that could also serve as a model for the rest of the country. He stressed the need for reforms from Class 1 to 12, bridging the gaps in school education, and strengthening higher education

institutions like Osmania and Kakatiya Universities, which once played a key role in Telangana's educational growth.

He added that he had urged the union Finance Minister to exempt education loans from the scope of the FRBM Act to ensure better financial support for students. Revanth Reddy assured that he was ready to face any political challenges if necessary for the sake of society and the future of children.


Op Sindoor, surgical strike & Balakot show India's resolve, says Rajnath

Hyderabad, Sep 17: Defence Minister Rajnath Singh today said Operation Sindoor, the 2016 surgical strike, and the 2019 Balakot air strike are proof that India resorts to hard power when negotiations fail to bring results.

He was addressing the Hyderabad Liberation Day celebrations in Telangana. "India's patience is its strength, not weakness. While a 'New India' under Prime Minister Narendra Modi believes in dialogue, we know how to give a befitting reply to those who fail to understand the language of peace," Singh said.

He underlined that terrorists who killed innocents in Pahalgam based on "dharma" were neutralised by the armed forces during Operation Sindoor based on "karma." He added that the operation is only on hold and will resume in full force if terror activities are staged from across the border.



Rejecting any third party mediation, the Defence Minister said no external power can interfere in India's internal matters. He credited the armed forces' valour for the successful operations and reiterated India's readiness to protect its unity.

Hailing Sardar Vallabhbhai Patel's deci-

sive role in integrating Hyderabad through Operation Polo in 1948. Singh called it a historic blow to the Razakars' conspiracy. "Just as the Razakars' conspiracy collapsed in 1948, Pakistan sponsored terrorism has failed today. Our unity and cultural diversity are our greatest strength," he asserted.

"Today, India does not take dictation from anyone; it writes its own script," he remarked.



Kerala attracts Rs 70.916 cr investment proposals over 5 years

Thiruvananthapuram, Sep 17 (UNI) Kerala has attracted fresh investment proposals worth Rs 70,916 crore between 2021-22 and 2024-25, reaffirming its growth momentum in tourism, IT, MSMEs, and green energy, according to a study by the MSME Export Promotion Council (EPC).

Releasing the report on "Investment, Growth & Development in Progressive Kerala," MSME EPC Chairman Dr. D S Rawat said completed projects during the period were worth Rs 23,728 crore, while Rs 10,780 crore worth of stalled projects were revived. Ongoing projects under various stages of implementation amounted to Rs 3,03,720 crore. The data were sourced from the Centre for Monitoring Indian Economy (CMIE).

In FY 2024-25 alone, new projects announced were worth Rs 11,544 crore, with the private sector contributing Rs 8,119 crore. Completed projects stood at Rs 2,944 crore, while revived ones were valued at Rs 867 crore. Highlighting the state's steady progress, the study noted that Kerala continues to maintain its status as one of India's most socially progressive states, combining economic expansion with welfare measures.

The report flagged notable growth in IT, tourism, healthcare, education, and MSMEs, while identifying green energy, knowledge economy, and start-ups as emerging areas. On the tourism front, Kerala has fully recovered from the pandemic, drawing over 2.20 crore visitors in 2024, contributing 10-12% to state GDP and providing employment to nearly 15 lakh peo-

CBI Court sentences ex-Central Excise Inspector, trader to 5 years in Rs 32.28 cr fraud case

Visakhapatnam, Sep 17 (UNI) The CBI Court in Visakhapatnam on Tuesday convicted and sentenced former Central Excise and Customs Inspector Kalaka Ramdas, private individual Polaki Janakiram, and M/s Sri Balaji General Trading Company in a Rs 32.28 crore fraud case.

The court awarded five years' imprisonment to both Ramdas and Janakiram, along with fines of Rs 1,01,000 and Rs 2,51,000, respectively. The company, represented by Janakiram, was fined Rs 2,01,000, bringing the total fine to Rs 5,53,000.

According to the CBI statement issued on Wednesday, the case was registered in 2005 after Janakiram conspired with Ramdas to cheat Customs and Excise by impersonating a non-existent individual, P Kesava Rao. They fraudulently established M/s Sri Balaji General Trading Company, secured trading licences and warehousing approvals through forged documents, and procured duty-free materials which were cleared as deemed exports in violation of EXIM policy guidelines. This caused a loss of Rs 32.28 crore in excise and customs duties.

Following the investigation, the CBI filed its chargesheet in 2008. After trial, the court convicted the accused, and both Ramdas and Janakiram were sent to Central Prison, Visakhapatnam.



Over 3 billion people worldwide depend upon water that crosses national boundaries. Yet, only 24 countries have cooperation agreements for all their shared waters.

TRUMP'S IMMIGRATION WARNING: STOP THE INVASION OR FACE CULTURAL COLLAPSE

Donald Trump sees illegal immigration not as a policy challenge, but as a worldwide emergency—a full-scale "invasion" that he believes is rapidly destroying Western countries. He uses Europe's struggles as a clear warning sign of what the United States must avoid.

The core of Mr. Trump's message is that immigration is "killing Europe." He constantly urges European leaders to "get your act together or you're not going to have Europe anymore." He argues that the large number of new arrivals, especially from specific regions, is causing countries to "lose their culture" and their unique identity. He

calls this change "very negative" and a threat to civilization. He often points to fears about churches being bought and converted into mosques, or the rise of separate legal systems like Sharia centers, as proof that Western culture is being threatened.

In his view, people are not arriving because they love the host country; they come primarily "to make money." He insists they are economic migrants who are simply lying to get asylum so they can take advantage of the generous welfare systems that provide free housing, food, and benefits for those out of work. He believes this system is being heavily exploited and is putting a huge financial and social burden on citizens, including legal migrants who followed the rules.

Mr. Trump is fiercely critical of the quality of people arriving, arguing that expecting them to be "doctors and engineers" is foolish. Instead, he claims many bring "nothing but violence." He frequently connects migrants to major crime, asserting that countries are allowing the entry of "migrant rape gangs, drug lords, murderers, and people from mental institutions." He considers this threat from criminal migrants to be so severe that it is more serious than traditional military dangers, like that posed



Russian President Vladimir Putin. He believes that this new crime wave is one of the biggest crises facing countries from the UK and France to Germany and the US. He has pointed to scandals in the UK, such as the sexual assaults by socalled "grooming gangs" (which he links to specific Pakistani, Afghan, and Moroccan backgrounds), as proof of the destructive impact of unchecked borders on local communities.

Because local communities are feeling pushed to their limits, Mr. Trump argues that a backlash is "inevitable." He describes the pressure as building up like a volcano—ready for an explosion. He believes that societies are finally "waking up" to the problems of open borders, and this will lead to a political revolt. His prediction

is that this tension will cause the rise of the far-right in Europe, as people turn to leaders who promise to protect their nation. He openly supports these "patriots" who take a hard line on immigra-

The solution, in Mr. Trump's view, requires extreme action. He calls illegal immigration a "cancer" that must be immediately addressed with force. He arques that countries must perform swift, mass deportations to remove those who have entered illegally. He is confident that when this crackdown happens, many Muslims and other illegal migrants will be "forced to re-

Netanyahu to meet Trump on Sept 29 in Washington

Jerusalem/Washington, Sept 17 (UNI) US President Donald Trump has invited Israeli Prime Minister Benjamin Netanyahu to the White House on September 29, the Israeli premier said on Tuesday, three days after he is due to address the UN General Assembly in New York, reports Times of Israel

Netanyahu announced the invitation at a Jerusalem press conference in which he discussed Israel's economy and issued a renewed warning to Hamas over the safety of hostages as Israeli forces press into Gaza City.

"This will be our fourth meeting in the White House since President Trump's second term began in January," Netanyahu remarked, adding that the invitation came during a phone call on Monday and that subsequent conversations with Trump had been "good."

Netanyahu announced the meeting during a press conference focusing on the state of Israel's economy, after he faced intense criticism for saying a day earlier that the country would need to become increasingly selfreliant.

However, he later issued a clarification over his remarks, stating that they pertained only to the defence sector which needed increased self-reliance, as the country is now facing an economic embargo -- particularly for weapon sales.

His comments come amidst the backdrop of the ground forces launched a full scale assault on Gaza City to capture it, amplifying its efforts to dismantle the terror group completely, with thousands

"And this is what I say to Hamas' leaders," tanyahu continued, "You will have no shelter anyway. But our effort to reach you will be redoubled sevenfold, and we will reach you much faster than you think."

He had been found guilty of intelligence and security cooperation with Israel by selling sensitive information about Iranian data centers to Mossad in return for money and the citizenship of a third country, the report said.

According to Mizan, Shahbazi had been working as a contractor designing and installing industrial cooling devices with companies affiliated with Iran's telecommunication, military and security organizations and centers.

At the international level, the Iraq War, the Russia-Ukraine conflict, the US elections, and the COVID-19 pandemic are global examples of this. Lies may travel around the world, but truth always finds its way, albeit late. Today's challenge is that democracy, media, and technology work together to accelerate the journey of truth and slow down the pace of lies.

New Delhi, Sep 17 (UNI) Microsoft's Digital Crimes Unit (DCU) has disrupted RaccoonO365 the fastest-growing tool used by cybercriminals to steal Microsoft 365 usernames and passwords ("credentials") said an official statement.

'RaccoonO365' is a lesser-known threat group that operates a Phishing-as-a-Service (PaaS) model that offers phishing assets, links and related tools.

The official statement said "Using a court order granted by the Southern District of New York, the DCU seized 338 websites associated with the popular servdisrupting the operation's technical infrastructure and cutting off crim-

regular upgrades to meet rising demand. This rapid growth underscores why taking legal action now is crucial to stop RaccoonO365 activities, said official document.


