Hyderabad declares three-day holiday for Jubilee Hills bypoll

Hyderabad, Nov 7 : The Hyderabad district administration on Friday declared a three-day paid holiday for offices and institutions where polling stations and counting centres have been set up for the Jubilee Hills Assembly constituency bypoll scheduled for November 11.

As per an order issued by Hyderabad Collector Harichandana Dasari, a holiday has been declared on the day of polling on November 11. In addition, a day before polling i.e., November 10 and counting day i.e. November 14 have also been declared a holiday for offices and institutions where polling stations and counting centres have been established.

Campaigning peaks in Jubilee Hills ahead of Nov 11 bypoll

‘Bade bhai Chote bhai’ camaraderie with Modi is working, claims Revanth Reddy

Hyderabad, Nov 7 : Even as he repeated his now familiar rhetoric of a cash crunch and consequent inability to keep poll promises, Chief Minister A Revanth Reddy claimed that his ‘Bade bhai Chote bhai’ camaraderie with Prime Minister Narendra Modi was working well for his government.

The statement, made during an informal chat on Friday, and which came as an embarrassment to the Congress high command that has relentlessly been targeting Modi, saw Revanth Reddy claiming that his “cordial relations” with Modi had helped him secure the Centre to approve a Rs 26,000 crore debt restructuring plan and also the northern part of the proposed Regional Ring Road.

He also said that while former Chief Minister YS Rajasekhara Reddy had tried hard but failed to secure defence lands for executing the elevated corridor on the JBS Shamirpet route, he had managed to obtain the defence

lands using his “relations” with the Centre.

“If the BJP leaders here do not create any hurdles, I will get many more projects approved,” he claimed.



With an obvious eye on the Jubilee Hills bypoll, Revanth Reddy also revealed plans to auction 250 acres that were allocated to the Hyderabad Metro Rail to mop up Rs 15,000 crore, which he said would make the Metro Rail takeover a “zero value” move for the State government.

“But instead of complimenting me for avoiding financial burden on the State exchequer, the

BJP and BRS are creating hurdles for Metro Phase II expansion,” he alleged.

Interestingly, even as he made tall claims of getting debts restructured and saving the exchequer, Revanth Reddy repeated his refrain on a severe cash crunch debilitating the government.

After paying employee salaries and clearing debts, the State government was left with about Rs 5,000 crore monthly. With these funds, it has to implement welfare and development programmes, besides providing retirement benefits for government employees.

On average, every month about 1,000 employees retire from service, resulting in an additional burden of nearly Rs.1,000 crore as pensions. The State's income was not rising and loans were not being sanctioned, he said.

“The situation is not going to change, no matter if you stage bandhs or point guns at me,” he said.

TTD EO Warns Devotees: Shun Brokers, Book Srivari Darshan Online Only

Tirumala, Nov 7 : TTD Executive Officer Anil Kumar Singhal appealed to devotees not to trust or be cheated by brokers promising Srivari Darshan tickets. The EO made this statement while addressing the media after the ‘Dial Your EO’ program held at Annamayya Bhavan in Tirumala on Friday.

Major Announcements and Decisions

1. Warning Against Scams:

The EO noted that TTD has been receiving frequent complaints, including recent ones from Hyderabad devotees, about being duped by brokers for darshan tickets. He reiterated the plea to devotees to use only official online channels for booking tickets and avoid dealing with unauthorized agents.

2. Infrastructure and Development: Permanent Shelters:

TTD has decided to allocate nearly ₹25 crore for the construction of permanent shelters and steel foot over bridges stretching



from the Alwar Tank Guest House to the Gogarbham Dam Circle in Tirumala, aimed at enhancing pilgrim convenience.

Amravati Temple Expansion: Development works, including the construction of the temple courtyard (prakaram), Kalyanotsava Mandapam, and Rajagopuram at the Sri Venkateswara Swamy Temple in Venkatapalem, Amaravati, will commence on November 27.

3. Brahmotsavams and Governance:

Karthika Brahmotsavams: The annual Karthika Brahmotsavams for Goddess Sri Padmavathi Devi at Tiruchanur will be conducted grandly from November 17 to 25.

Darshan Token Review: A TTD Board committee has been constituted to study the current

system of issuing Srivani and other darshan tokens based on pilgrim feedback. Further action will be taken based on the committee’s report.

Annarasadam: Measures are being implemented to ensure the distribution of Annarasadam (free meals) in TTD temples is scaled up according to the pilgrim rush in those areas.

4. Social and Environmental Initiatives:

Srivani Trust: The TTD Board decided to construct 5,000 Bhajana Mandirams (prayer halls) in backward areas of the state using ₹750 crore from the Srivani Trust funds.

Biodiversity: The TTD Board has resolved to take steps to protect biodiversity and enhance greenery in the Tirumala forest region over the next 10 years.

Shabbir Ali campaigns at mosque ahead of Jubilee Hills bypoll

Hyderabad, Nov 7 : In yet another violation of the model code of conduct ahead of Jubilee Hills bypoll, Telangana Government Advisor Mohd Shabbir Ali on Friday campaigned at a mosque and appealed to the Muslim community to recognise the power of their vote.

He addressed worshippers at the Masjid-e-Kaneez Fatima in Madhura Nagar, Ameerpet before the Friday prayers. “Every vote cast by a citizen carries the weight of their identity, dignity and collective voice,” he told the gathering, stressing that the survival and influence of any community in a democratic system depended on its participation in elections.

“We are nearly 13% of Telangana’s population, but if we do not vote, our presence does not count. A community that remains silent during elections loses its voice for the next five years,” Shabbir Ali said.

Harish Rao predicts silent revolution in Jubilee Hills

Hyderabad, Nov 7 : Former Minister and senior BRS MLA T Harish Rao on Friday predicted a silent revolution in the Jubilee Hills bypoll, asserting that people would decisively vote for the Car symbol to safeguard Telangana’s future and expose the Congress government’s failures.

Emphasising the need for a strong voice to question the Revanth Reddy government, which he described as marked by misrule, intimidation, and administrative collapse, he said there were only two teams — one that promised six guarantees and another that fought for their implementation. “People should decide between development and destruction,” he said, urging voters to support BRS candidate Maganti Sunitha.

Fielding a volley of questions during a Meet the Press programme at the Press Club of Hyderabad in Somajiguda, Harish Rao said whether in power or opposition, BRS had always stood with the people. “When houses were demolished in the name of HYDRABAD, we fought for justice. Mohammed Azharuddin became a Minister because BRS questioned injustice to minorities,” he charged.

He lambasted the Congress government for complete regression in all sectors except crime, citing official police reports to show how law and order had deteriorated since December 2023. “From January to September 2025 alone, there were 189 murders, 1,700 kidnappings, 123 rape cases, 1,051 robberies, and over 6,400 house thefts. Crimes against women rose by 12.3 per cent, rapes by 28 per cent, and kidnappings by 26 per cent. Hyderabad, once an investment hub under KCR, has now turned into an insecurity hub,” he said.

The former Minister compared this to the previous BRS regime, which established the Integrated Command Control Centre and installed around 10 lakh CCTV cameras, including six lakh in Hyderabad. “Revanth Reddy reduced the Command Control Centre to a venue for review meetings, while most CCTV cameras remain defunct due to lack of maintenance. Murders are happening in broad daylight, while police act like political agents. Drugs worth thou-



sands of crores were seized in Cherlapalli by Mumbai police, which is a shameful blot on the government,” he remarked.

On the Congress government’s borrowings, Harish Rao said the State’s debt had increased by Rs 2.08 lakh crore in just two years. “The State’s own tax revenue, which was 12 per cent under BRS, has fallen drastically. Revanth Reddy has stopped welfare schemes citing lack of funds, yet he is ready to spend Rs 1.5 lakh crore each on the non-existent Future City and Musi Riverfront projects designed for commissions,” he al-

leged.

Responding to questions about Kavitha’s allegations, he said the Congress was indulging in political diversion to cover up its failures. “If anyone must answer, it is Revanth Reddy, as his own colleague Konda Surekha’s daughter accused him of extortion and gun threats,” he countered.

On the Kaleshwaram project issue, he rubbished allegations of BRS-BJP collusion. “If Revanth truly had no ties with the BJP, why hasn’t the ED questioned him in the Vote-for-Note case? He would have been behind bars long ago,” he quipped.

Harish Rao dismissed the Congress’s claims about constructing the Tummididi Hatti project. “Only 80 TMCft of water is available there, while the Kaleshwaram project draws 280 TMCft. By proposing to divert water from Tummididi Hatti to the Sundilla barrage, Revanth Reddy has admitted that the Kaleshwaram project is sound. Tummididi Hatti is only a scheme for contracts and commissions,”

he stated.

On HYDRABAD demolitions, he said BRS had stood by the poor when their homes were destroyed at midnight and on weekends. “If HYDRABAD acts as per law, we support it. But why target only the poor while letting the rich go free?” he asked.

Questioned about the Jubilee Hills dynamics, Harish Rao said Sunitha, as a woman candidate, would connect better with voters. “Gopinath was a strong leader, and Sunitha will represent people’s voice with the full backing of BRS,” he said.

Alleging misuse of the police machinery, the former Minister demanded the deployment of Central Armed Police Forces (CAPF) to ensure a fair bypoll. “The DGP, who took his appointment letter from the Chief Minister, cannot be expected to act independently,” he remarked.

Harish Rao concluded by declaring that the BRS, which aims to bring K Chandrashekhara Rao back as Chief Minister, would continue to be the voice of the people both inside and outside the Assembly.

“The people of Telangana want KCR back, and Jubilee Hills will mark the beginning of that return,” he asserted.

Shah added that under the leadership of Prime Minister Narendra Modi, the collective efforts of the nation over the past 11 years have accomplished many tasks toward fulfilling the dreams of a great India envisioned by our freedom fighters.

Transport systems similar to the RRTS will be developed in other major cities apart from Delhi : Manohar Lal

New Delhi, Nov 7 (PIB) The 18th edition of the Urban Mobility India (UMI) Conference & Exhibition 2025 was inaugurated today by Manohar Lal, Hon’ble Union Minister of Housing & Urban Affairs and Power, in Gurugram, Haryana.

The inaugural session was graced by Tokhan Sahu, Minister of State for Housing and Urban Affairs; Srinivas Katikithala, Secretary, MoHUA; Dr. Raja Sekhar Vundru, Additional Chief Secretary (Transport), Government of Haryana; and Dr. Chander Shekhar Khare, Managing Director, GMRL.

The event witnessed the presence of senior officials from Central and State Governments, Managing Directors of Metro Rail Companies, heads of transport undertakings, international experts, and representatives from academic and research institutions. Over 1600 professionals and academicians are participating in this year’s conference.

The three-day event is being jointly organized by the Ministry of Housing and Urban Affairs (MoHUA), Government of India, and the Government of Haryana, through the Institute of Urban Transport (India) and Gurugram Metro Rail Limited (GMRL).

The 2025 edition focuses on the theme ‘Urban Development and Mobility Nexus’, highlighting the interlinkages between urban planning and mobility systems, and their collective impact on economic growth, environmental sustainability, social equity, and public health.

In his inaugural address, Manohar Lal extended greetings on the 150th anniversary of the national song ‘Vande Mataram’, and lauded the contribution of the UMI conference in shaping India’s mobility ecosystem. He highlighted that with nearly 1,100 km of operational metro network, India has become the third-largest metro network in the world, soon to attain the second position. Referring to the PM e-Bus Sewa, the Minister announced the deployment of 10,000 electric buses across smaller cities, with 100 e-buses earmarked for Gurugram.

The Minister further underlined that last-mile connectivity remains a critical challenge to improving metro ridership and assured that the Ministry will work closely with States to implement effective measures in this regard.

Union Minister Manohar Lal also said that Delhi Metro Rail Corporation (DMRC), through its subsidiary — Delhi Metro International Limited (DMIL) — will act as the nodal agency on behalf of the Ministry of Housing and Urban Affairs (MoHUA) for executing consultancy, construction, turnkey projects, management services, and operation and maintenance-related projects in India and abroad.

He also informed that it has also been decided that DMRC, through another of its subsidiaries, will act as the nodal organization to support MoHUA in the planning, coordination, and management of Mass Rapid Transit Systems (MRTS) across the country.

In his address, Union Minister Manohar Lal also stated that transport systems similar to the RRTS will be developed in other major cities.

Speaking on the occasion, Tokhan Sahu, Minister of State for Housing and Urban Affairs, stated that mobility is not merely a mode of transport but a driver of socio-economic growth. He emphasised that initiatives such as Transit Oriented Development (TOD) and the National Common Mobility Card (NCMC) are transforming urban mobility and enhancing commuter experience across India.

Srinivas Katikithala, Secretary, MoHUA, in his remarks, stressed the importance of integrated urban development and mobility planning to enhance the livability and sustainability of Indian cities.

The conference will feature plenary sessions, panel discussions, and technical presentations focusing on innovations and policy frameworks to build future-ready, inclusive, and sustainable urban mobility systems in India.

Union Minister Manohar Lal inaugurated the exhibition at the Urban Mobility India Conference 2025 and took a ride in a retrofitted Electric Auto, converted from CNG. The initiative highlights India’s innovation in sustainable and inclusive urban transport.

Electricity (Amendment) Bill 2025: Why Being Opposed En Masse?

Voices of protest against the India Government’s Electricity (Amendment) Bill 2025 have begun to emerge en masse stating it as anti-farmer, anti-consumer, and anti-employee. The power employees, engineers, farmers and consumers have started to come on the same page to oppose it.

In a meeting of the National Coordination Committee of Electricity Employees and Engineers (NCCOEEE) held in Mumbai on 03 November 2025, it has been decided that 2.7 million power employees and engineers across the country will be forced to launch a nationwide movement against the Electricity (Amendment) Bill 2025 and the privatization of the power sector, if the Government of India fails to listen to their voice.

Acting on the strategy prepared for the nationwide agitation against the Electricity (Amendment) Bill 2025, a united front with the leaders of the electricity employees, Samyukta Kisan Morcha, All India Trade Unions and common consumers will be formed.

State-level joint conventions of NCCOEEE will be held in November, December, and January in all states to mobilize employees and engineers against privatization and the Electricity (Amendment) Bill 2025, and a call will be given for ‘Delhi Chalo’ on 30 January 2026.

Taking a lead, complying with the decisions of the National committee, All Haryana Power Corporations Workers Union organised a state-level convention on 5th November in Rohtak against the Electricity (Amendment) Bill and accusing the power corporation management of ignoring the demands of the employees and promoting privatization, announced to protest at the Panchkula headquarters of ACS Power on November 26.

Now the questions arise—Why the NCCOEEE is opposing the bill? How will this bill affect the present scenario?

Explaining the ill effects, in a statement issued by Sudip Dutta, convener on 4th November, quoted that the NCCOEEE leaders have shown their concern that through the Electricity (Amendment) Bill 2025, the Central Government wants to privatize the entire energy sector of the country. After privatization, electricity rates will become so high that they will be beyond the reach of farmers and common consumers.

In the press conference attended by leaders of NCCOEEE - Shailendra Dubey, Comrade Mohan Sharma, Convenor Comrade Sudip Dutta, Comrade Krishna Bhojyar, Ratnakar Rao, Sanjay Thakur, Laxman Rathod it was explained how the bill has negative impact.

“Through Sections 14, 42, and 43 of the Amendment Bill, private companies are being given the right to use the network of government electricity distribution companies to supply power, and in return, they will pay only nominal wheeling charges to the government DISCOMs. This will mark the beginning of the end of electricity distribution in the government sector” fears NCCOEEE.

Committee further explained that the entire responsibility for the maintenance and strengthening of the network will lie with the government distribution companies. The financial burden of this will fall on the government electricity distribution corporations, while private companies will be given the freedom to earn money through this network.

Under this Amendment Bill, private companies will not have the obligation of uninterrupted power supply. The adverse consequence will be that private companies will use the government company’s network to supply electricity to profitable industrial and commercial consumers, while the responsibility of supplying power to farmers and poor domestic consumers will remain with the government electricity distribution corporations. As a result, government electricity distribution companies will become bankrupt and will not even have money to purchase electricity or pay salaries to their employees.

How will the farmers be looted in the shadow of the new bill?

NCCOEEE stated that the Amendment Bill proposes to amend Section 61(g) to eliminate cross-subsidy within the next five years. Along with this, the Bill provides that electricity tariffs should be cost-reflective, meaning no consumer should be supplied electricity at a price lower than the cost. This means that farmers will have to pay at least Rs. 12,000 per month as an electricity bill for a 6.5 horsepower pump if it runs for six hours a day. Similarly, electricity rates for consumers below the poverty line will become at least Rs. 10–12 per unit. Further, the Bill proposes to promote virtual power markets and market-based trading systems. This will destabilize long-term agreements and make the cost of power more volatile.

Is the bill against the federal structure of the country? NCCOEEE cautions that presently the electricity is listed in the Seventh Schedule of the Constitution under the Concurrent List, which means that the central and state governments have equal rights in matters of electricity. But through this Amendment Bill, the Central Government is taking away the rights of the states in electricity matters, and there will be direct intervention by the Central Government in electricity distribution and tariff determination, which is against the federal structure and spirit of the Constitution.

Farmers’ unions have also jumped into the fray. Participating in the convention at Rohtak, Haryana, National Vice President of All India Kisan Sabha, Comrade Inderjeet Singh announced that farmers will also strongly oppose the Electricity Amendment Bill being brought to privatize electricity and the installation of smart meters.

Bharatiya Kisan Union Ekta Dakonda, Punjab has also come forward to support the agitation against the electricity bill. Angeez Singh Bhadaur, State Press Secretary, informed our representative that in the meeting of the Kisan union, it has been passed that the Electricity Amendment Bill-2025 is being brought by the central government in violation of the promise made to the farmers and this is a ploy to implement privatization in the field of electricity distribution. Therefore, the Electricity Amendment Bill 2025 will be opposed with full force.

Bhadaur further stated that the Samyukta Kisan Morcha is scheduled to march towards Chandigarh on November 26 and a pre-march meeting will be held at Kisan Bhawan, Chandigarh on November 17 to make concrete plans for this march. The main demands of that march will include the demand for cancelling the Electricity Amendment Bill.

The government should not remain so adamant and rigid while deciding such sensitive issues and always keep in mind the 13 months long farmers’ agitation against three black agricultural laws wherein more than 700 farmers lost their lives and ultimately the central government had to repeal those laws.

Ministry of Ayush Scales up integrative cancer care through research, centres of excellence and community outreach

He was also known in the surrounding areas of Palamuru District. In those days when irrigation was not proper, he taught many people to prepare seeds themselves. Thus, he increased the dairy crops. He provided abundant

grain.

The little Ella Reddy with tails became a big name for all the surrounding villagers, regardless of caste and creed. Some leaders thought that if the villagers provided basic facilities in the villages, the villagers would abandon them. But unlike them, Chinna Ella Reddy provided roads, drinking water and other facilities to the village. He stood out like a big tree in the head of the villagers. He had three sons and six daughters. HPV Vaccine Essential for Preventing Cervical Cancer: SPMVV Expert

Tirupati, Nov 7 : An awareness program focusing on the prevention of Cervical Cancer through HPV Vaccination was organized by Dr. K. Himavathi, Associate Professor at the Centre for Women's Studies, Sri Padmavati Mahila Visavidyalayam (SPMVV). The session was conducted for girls at the Government Girls High School, Chinna Bazar Veedhi, on Friday, November 7, 2025.

Dr. Himavathi highlighted that according to the current data from the National Cancer Registration Programme (NCRP), cervical cancer, second only to breast cancer, is a leading cause of cancer mortality among women. Key Vaccination Guidelines

Dr. Himavathi emphasized that childhood vaccination against HPV is a crucial preventive measure. She provided the following key guidelines:

- Target Age Group:** The vaccine is mandatory for children between 9 and 14 years of age.
- Dosage:** Two doses (at 0 and 6 months) are required, administered with a six-month gap. She stressed that boys should



also be vaccinated to prevent them from contracting HPV-related cancers.

Catch-Up Vaccination: For those who missed the vaccination in childhood, a catch-up vaccine can be administered up to the age of 45 years.

Available Vaccines: Vaccines like Gardasil, Gardasil-9, and Cervix are available and effectively reduce the risk of cervical, vaginal, vulvar, and anal cancers, as well as genital warts caused by HPV. For men, the vaccine offers protection against mouth, throat, and penile cancers.

She also outlined the common symptoms and causes of cervical cancer. The vaccine is not recommended for pregnant women or individuals with acute illness. Dr. Himavathi called upon teachers, parents, and children to collaborate in prioritizing this vaccination to ensure the health of future citizens.
