



Bhatti Vikramarka Attends US 'Freedom 250' Celebrations in Hyderabad

Hyderabad : Telangana Deputy Chief Minister Bhatti Vikramarka Mallu participated in the 'Freedom 250' celebrations organised by the United States Consulate in Hyderabad to commemorate the 250th anniversary of American Independence.

Addressing the gathering, the Deputy Chief Minister highlighted the growing relationship between Telangana and the United States, describing it as a partnership built on strong cultural, educational and economic ties.

He noted that Telugu is among the fastest-growing languages in the United States, reflecting the deep people-to-people connections between the two regions.

Bhatti Vikramarka said cooperation between Telangana and the United States has expanded significantly beyond the information technology sector and now encompasses emerging areas such as artificial intelligence, clean energy, life sciences and aerospace.

He also advocated for the es-



establishment of a US development centre in Hyderabad, stating that such an initiative would further strengthen bilateral collaboration, attract global investments and reinforce the city's position as a leading innovation hub.

A major highlight of the event was the unveiling of a ceremonial plaque renaming the road adjoining the US Consulate in Nanakramguda's Financial District as "Donald Trump Avenue." According to officials, the initiative was undertaken by

the Telangana Government as a symbolic gesture recognising the importance of US-India relations and Hyderabad's growing role in fostering international partnerships.

The plaque was jointly unveiled by Sergio Gor, United States Ambassador to India, Bhatti Vikramarka Mallu, and Laura Williams, United States Consul General in Hyderabad.

The Deputy Chief Minister also appreciated the efforts of the US Consulate in incorporating re-

gional cultural elements into the design of its new consulate building and expressed confidence that cooperation between Telangana and the United States would continue to grow across strategic, economic and cultural sectors.

The event was attended by diplomats, government officials, business leaders and members of the Indian-American community, reflecting the close ties between Hyderabad and the United States.

HAL to Build ₹10-Crore Degree College in Dharmapuri Under CSR Initiative

Bonalu Festival to Be Celebrated on a Grand Scale Across Three Corporations: Konda Surekha

Hyderabad : The Telangana government is gearing up to celebrate the Ashada Bonalu festival on a grand scale this year, with elaborate arrangements being made across Hyderabad, Secunderabad, Rangareddy and Medchal-Malkajgiri districts, State Forest, Environment and Endowments Minister Konda Surekha said on Wednesday.

Participating virtually from London in a Bonalu coordination meeting held at the MCRHRD Institute, the minister said the festival is a reflection of Telangana's cultural identity, spiritual traditions and collective faith. She directed all departments to work in close coordination to ensure the smooth and successful conduct of the festivities.

Noting that Bonalu celebrations were earlier organised within a single corporation jurisdiction, Ms Surekha said this year's festivities would be conducted in a more expansive and magnificent manner across three corporation limits. She stressed that devotees should not face any inconvenience and instructed officials to make comprehensive arrangements.



The Bonalu festivities will begin at the Sri Jagadamba Mahankali Temple in Golconda on July 16 and continue until August 13 at temples across the region. Traditional events such as Ghatam processions, Bonam offerings, Thottela processions, Pothuraju performances, Rangam rituals and other customary ceremonies will showcase Telangana's rich cultural heritage, she said.

The minister thanked Chief Minister A. Revanth Reddy for allocating Rs 20 crore for the conduct of this year's Bonalu celebrations. She said the funds should be effectively utilised for improving temple infrastructure, decorative lighting, floral arrangements, CCTV surveillance, queue management, drinking water facilities, sanitation and medical camps.

Ms Surekha directed officials of the Endowments, GHMC, Police, Electricity, Roads and Buildings, Water Works, RTC, Railways, Health, Fire Services, Tourism and Information & Public Relations departments to work in coordination. Special traffic management plans, additional bus services, medical teams and security arrangements should be put in place at major temples expected to witness large crowds, she said.

The minister also instructed authorities to make special arrangements for senior citizens, pregnant women and lactating mothers, including the setting up of lactation rooms. Considering the expected influx of devotees from across the state, aided by the Mahalakshmi free bus travel scheme, she urged Transport Minister Ponnamp Prabhakar to ensure adequate transport facilities during the festival period.

DIG Chavan Inspects Zaheerabad DSP Office and Pulkal Police Station

Sangareddy : DIG Chavan conducted an inspection of the Zaheerabad DSP Office and Pulkal Police Station in Sangareddy District. District SP Paritosh Pankaj and Additional SP Chaitanya Reddy accompanied him during the visit. As part of the inspection, the officials planted saplings in the police station premises.

Land Acquisition Process Begins for KP Lakshmidivally Reservoir

We Will Not Rest Until Water Reaches the Fields: MLAs Veerlapally Shankar and Rammohan Reddy

First Step Towards Acquisition of 1,510 Acres; Farmers Urged to Cooperate

Shadnagar : The land acquisition process for the prestigious KP Lakshmidivally Reservoir, aimed at meeting the irrigation needs of Shadnagar and Pargi constituencies, officially commenced on Wednesday. A large public meeting was held at the proposed project site in Jilled Chowdarygudem Mandal of Rangareddy district, where Shadnagar MLA Veerlapally Shankar and Pargi MLA Rammohan Reddy addressed farmers and local residents.

The MLAs declared that they would not rest until water from the reservoir reaches the agricultural fields of both constituencies. They stated that they had repeatedly pursued the project with the Chief Minister, ministers, and senior officials, and that the State Government's allocation of ₹587 crore for land acquisition has paved the way for its implementation.

The meeting was attended by Rangareddy Additional Collector Chandra Reddy, Vikarabad Additional Collector Venkata Chari, Commissioner for Rehabilitation and Resettlement Shiv-



akumar Naidu, Irrigation Executive Engineer Dayanand, RDO N.R. Saritha, survey officials, public representatives, Congress leaders, and a large number of farmers.

Acquisition of 1,510 Acres

Officials informed that a total of 1,510 acres of land would be acquired for the reservoir. Of this, 278.35 acres fall within villages of Shadnagar constituency, while more than 800 acres are required in Saiduapally Pargi constituency. Another 83.31 acres will be acquired in Allapur village of Kulkacharla Mandal. Additional land may also be needed for canals and other associated infrastructure. Officials appealed to farmers to extend

full cooperation, assuring that all affected landowners would receive fair compensation as per government norms. They emphasized that the sacrifice of a limited number of farmers would benefit thousands of acres of agricultural land across the region.

A Historic Day for the Region

Addressing the gathering, both MLAs described the day as a historic milestone. They said the people of the region had been waiting for many years for the Lakshmidivally Reservoir and expressed happiness that the arrival of officials marked the beginning of the land acquisition process. They credited

Chief Minister Revanth Reddy, Deputy Chief Minister Bhatti Vikramarka, Minister Uttam Kumar Reddy, and senior officials for their support in bringing the project to this stage. Once completed, the reservoir is expected to transform agriculture and improve irrigation facilities in Shadnagar and Pargi constituencies.

Criticism of Previous Government

MLA Veerlapally Shankar criticized the previous government for neglecting the Lakshmidivally project despite making repeated promises. He alleged that the project was never taken forward seriously and stated that the present Congress

government is implementing it with commitment and sincerity. He further claimed that the cancellation of the Pranahita-Chevella project had adversely affected the region.

Beware of Misleading Propaganda

The MLAs alleged that certain opposition leaders were attempting to mislead and provoke farmers as the project moves forward. They urged farmers not to be influenced by such campaigns and assured them that the government would stand by all displaced families and ensure justice through adequate compensation and rehabilitation measures.

HYDRA Fences 5 Acres of Government Land in IT Corridor; Saves Property Worth Rs. 1,000 Crore

HYDERABAD : In a major crackdown, the Hyderabad Disaster Response and Assets Monitoring and Protection Agency (HYDRA) safeguarded 5 acres of prime government land in Khanamet village under Serilingampally mandal of Rangareddy district.

Some individuals had allegedly attempted to encroach upon this highly valuable land, located under Survey Number 42 on the bustling stretch connecting Metal Charminar to the Hitec Exhibition Centre. The encroachers had erected two temporary sheds, constructed a room, and were in the process of building a boundary wall using tin sheets around the entire 5-acre expanse. For years, claimants had asserted private ownership over this parcel, restricting others from entering the area.

Following an official complaint and request from the Serilingampally revenue authorities, HYDRA personnel swiftly intervened at the site. The teams demolished the two temporary sheds, the newly constructed room, and dismantled the illegal tin fencing.

After completely clearing the encroachments, HYDRA secured the 5 acres of government land by installing its own protective fencing and setting up official signboards declaring it as government property. According to official estimates, the market value of this reclaimed land in the heart of the IT corridor is approximately ₹1,000 crore.

Theft Spree Driven by Habit of Extravagant Living

Miryalaguda Two-Town Police arrest two thieves and solve multiple theft cases

Miryalaguda : Miryalaguda Two-Town CI Jatti Soma Narasaiah announced at a press conference that the police had solved a chain-snatching case and arrested two accused individuals within the Two-Town police station limits. He stated that the investigation revealed the accused Ajmeera Shashidhar Naik and Dhanavath Karthik had turned to crime to make easy money after becoming addicted to vices while working as Rapido riders in Hy-

derabad. They had planned to use a stolen Honda Activa scooter (taken from a parking spot in Hyderabad) for chain-snatching activities. On June 17, in the Santoshnagar area of Miryalaguda, they snatched a gold chain from a woman working in front of her house and fled.

The investigation further revealed that they pledged the stolen chain at Manappuram Finance in Miryalaguda and obtained a loan of ₹1,22,000, subsequently sharing and

spending the money.

On the morning of June 24, while police were conducting vehicle checks near the Hanumanpet flyover in Miryalaguda, the accused attempted to flee upon seeing the officers; they were detained on suspicion and interrogated, during which they confessed to the crime and [revealed details about] the vehicle used in the offense. It was stated that details regarding the vehicles and other items were disclosed, and the accused were subsequently remanded to custody on Wednesday.

District SP Sharath Chandra Pawar (IPS) commended the team that solved the case led by Miryalaguda Two-Town Inspector Jeti Soma Narasaiah, Sub-Inspector A. Satish, comprising staff members R. Collector Khushboo Gupta Calls for Intensive Anti-Drug Awareness Programmes in Schools and Colleges

NCORD Meeting Reviews Drug Control Measures; Nasha Mukh Bharat Abhiyan Awareness Rally to Be Held Today June 25

MAHABUBNAGAR : District Collector Khushboo Gupta has directed officials to conduct extensive awareness programmes in schools and colleges across the district to eradicate drug abuse and ganja consumption among youth. She emphasized the need for coordinated efforts by all departments to prevent the spread of narcotic substances and protect students from addiction.

The Collector chaired the Narcotic Coordination District Committee (NCORD) meeting at the District Collectorate Video Conference Hall on Wednesday along with Superintendent of Police D. Janaki and officials from various departments. The meeting reviewed measures being implemented to curb drug abuse, prevent illegal trafficking of narcotic substances, create awareness among youth, and strengthen preventive action in educational

institutions. Addressing the officials, the Collector stressed that the Police, Education, Welfare, Health, and other concerned departments must work in close coordination to effectively control drug abuse and illegal trafficking. She instructed officials to maintain constant surveillance on suspicious activities and intensify awareness campaigns among students. Awareness programmes should be conducted in both government and private schools and colleges to educate students about the harmful effects of narcotic substances.

Superintendent of Police D. Janaki stated that the Government of India is implementing several initiatives nationwide under the theme "Nasha Mukh Bharat Abhiyan - Viksit Bharat Ki Pehchaan" to combat drug abuse. As part of the campaign, awareness programmes are being conducted across the district



from June 17 to June 26. She informed that the Police Department has organized several awareness activities since June 22 focusing on drug abuse prevention and eradication of narcotic substances.

The SP emphasized that effective control of drug abuse and illegal trafficking can be achieved only through coordinated efforts of all departments and urged education officials to closely monitor students and immediately report any suspicious

cases to the police. During the meeting, the Collector reviewed the actions taken by the Excise Department to curb illegal drug trafficking and supply.

Excise officials informed that two cases were registered during the previous month, resulting in the seizure of 3.5 kilograms of ganja and the arrest of three accused persons. They further stated that six cases have been registered since January 2026, leading to the arrest of 20 individuals in-

volved in drug-related offences. The Collector also directed Drug Control Department officials to maintain strict vigilance over the sale of habit-forming medicines in medical shops. She instructed them to conduct regular inspections, hold periodic meetings with medical shop owners and pharmaceutical suppliers, and create awareness regarding the illegal sale of addictive drugs.

She further ordered that principals of all medical colleges in the district and representatives of Palamuru University should be made mandatory participants in future NCORD meetings. Education Department officials were instructed to train teachers to identify students and youth who may be vulnerable to drug addiction in villages and educational institutions and immediately share such information with the police.

The Collector also di-

rected police officials to intensify surveillance on the illegal supply and sale of narcotic substances, conduct frequent inspections of shops and other suspected locations, and take stringent action against those violating the law. Meanwhile, District Welfare Department officials announced that a Nasha Mukh Bharat Abhiyan awareness rally will be organized on June 25 at 9:30 a.m. from the District Stadium Ground to Ambedkar Chowk to spread awareness on drug control and prevention.

The Education Department has been requested to mobilize large numbers of students from schools and colleges to ensure the success of the rally. DSP Venkateshwarlu, District Women and Child Welfare Officer Zarina Begum, District Education Officer Vijay Kumar, and officials from the Excise and Health Departments attended the meeting.

BTPS Donates Rs. 1.45 Lakh CSR Funds for Manuguru Govt Polytechnic College Development

He emphasized prioritizing un-

Presenting the district's performance report, Collector Koya Sriharsha revealed that the 99-Day Program was successfully executed

Editorial BRICS Space Cooperation as a driver of innovation

Union Minister Dr. Jitendra Singh pitched for "BRICS Space Economy" as the next frontier of global growth and called for collective action among member nations to unlock new opportunities in innovation, investment, entrepreneurship and sustainable development.

Addressing the Valedictory Session of the BRICS Heads of Space Agencies (HOSA) Meeting in Bengaluru, Dr. Jitendra Singh said BRICS countries possess the scale, scientific capabilities, technological strengths and industrial capacity required to emerge as a major force in the rapidly expanding global space economy. "The future of the space

economy will not be shaped by nations working in isolation. It will be shaped by partnerships, shared innovation and collective ambition. BRICS countries have the potential to become one of the strongest pillars of this emerging global space ecosystem," Dr. Jitendra Singh said.

The Minister also released the Indian Space Industry Brochure, exchanged mementoes with the Heads of Space Agencies participating in the meeting and interacted with representatives of India's fast-growing NewSpace sector. The interaction showcased the growing capabilities of Indian space startups and private enterprises before the visiting

BRICS delegations.

Hosted by the Indian Space Research Organisation (ISRO) under India's BRICS Chairship 2026, the two-day meeting brought together Heads of Space Agencies and senior officials from Brazil, China, Egypt, Ethiopia, Indonesia, Iran, Russia, South Africa and the United Arab Emirates. Chairman, ISRO and Secretary, Department of Space Dr. V. Narayanan, Chairman, IN-SPACe Dr. Pawan Goenka, senior officials from the Department of Space, representatives of Indian space industries and NewSpace startups also participated in the concluding session.

The meeting reviewed progress in BRICS space coop-

eration and deliberated on key issues including space sustainability, debris-free missions, strengthening the BRICS Remote Sensing Satellite Constellation (RSSC), expanding participation of new BRICS members in existing cooperation mechanisms, and advancing discussions on the proposed BRICS Space Council. Deliberations also covered future collaboration in disaster management, Earth observation, capacity building and knowledge sharing.

Dr. Jitendra Singh said that space technology has emerged as one of the most powerful drivers of economic transformation and societal progress, enabling countries to strengthen

communication networks, navigation systems, disaster preparedness, agriculture, healthcare, education and environmental monitoring. He said challenges such as climate change, natural disasters, food and water security, environmental degradation and sustainable urbanisation increasingly require collective solutions supported by advanced space technologies.

Referring to the growing role of BRICS in the global space landscape, the Minister said the grouping represents a significant share of the world's population, economic output, scientific expertise and technological capabilities. He said deeper cooperation among

BRICS countries can create new opportunities for innovation, industrial partnerships, technology transfer, investment and economic growth while addressing common developmental priorities.

Dr. Jitendra Singh said the BRICS Remote Sensing Satellite Constellation has already demonstrated the value of collaborative space applications through satellite data sharing among member countries. He expressed confidence that ongoing discussions on institutional mechanisms, including the proposed BRICS Space Council, would provide greater momentum and continuity to future cooperation in the space sector.

Election Commission's website voter.eci.gov.in.

Through this special amendment program, apart from correcting the errors in the voter list, names of deceased persons, duplicate votes for the same person in more than one place will be removed. Also, the main objective is to include

the name of every young woman and young man who is eligible to complete 18 years by October 1, 2026 in the final voter list.

The collector appealed to people not to believe false propaganda that votes will be lost due to SIR process. The BLOs will start the house-to-house survey from 8 am and asked all the people to give their full cooperation and secure their right to vote.

Collector Appeals for Full Cooperation in Special Intensive Revision (SIR) of Electoral Rolls

Suryapet : District Collector and District Election Officer Tejas Nand Lal Pawar has appealed to all political parties, public representatives, and officials to extend full cooperation in preparing a transparent electoral roll through the Special Intensive Revision (SIR) programme.

Speaking at an all-party meeting held at the VC Conference Hall on Wednesday regarding the SIR exercise, the Collector said that Booth Level Officers (BLOs) will conduct door-to-door visits from June 25 to July 24 as part of the revision process. During these visits, enumeration forms will be distributed to voters. He urged all political parties to cooperate in ensuring the smooth conduct of the programme and requested Booth Level Agents (BLAs) to provide complete support to

BLOs.

The Collector explained that, as per the directions of the Election Commission of India, the schedule for the Special Intensive Revision is as follows:

- June 25 – July 24: Door-to-door verification by BLOs
- July 24: Rationalization of polling stations
- July 31: Publication of the draft electoral roll
- July 31 – August 30: Receipt of objections and claims on the draft roll
- July 31 – September 28: Disposal of objections and claims
- October 1, 2026: Publication of the final electoral roll

He stated that during the door-to-door visits, BLOs will provide two enumeration forms to each voter. One copy will remain with the BLO, while the other will be given to the voter. If voters are unable



to submit their details directly through the form, they may also do so through the voter portal.

The Collector urged politi-

cal party representatives to identify and assist voters who may not have received or submitted enumeration forms, or whose names may have

been inadvertently omitted from the electoral rolls. He noted that BLOs, BLO Supervisors, and designated officials would remain in the field

for a month and asked the public to share relevant information with them.

Emphasizing that the SIR programme is being implemented strictly in accordance with Election Commission guidelines, he said there is no need for any misconceptions. He clarified that citizens can exercise their voting rights at their place of residence and requested BLAs to spread awareness among the public.

The Collector explained that the objective of the SIR exercise is to prepare a transparent electoral roll by removing duplicate entries, deceased voters, and those who have permanently shifted residence, ensuring that every eligible voter is included while ineligible persons are excluded.

He further informed that enumeration forms will be dis-

tributed from June 25 to June 28 and urged political party representatives to treat the exercise with utmost importance and ensure that forms reach all eligible voters.

Appealing to all voters, he requested them to provide complete information through the forms submitted to the BLOs during the door-to-door survey and called for widespread awareness of the Special Intensive Revision programme.

Speaking on the occasion, TSU leader Keshaboyina Muralikrishna and MSF Suryapet District President Panditi Naveen Kumar stated that they received complaints from parents alleging that Akshara School, located on Katakamagudem Road, was selling books at inflated prices without obtaining the required permis-

sions. When members of the student unions visited the school and questioned the management, they alleged that the school authorities behaved rudely and acted aggressively towards them.

Following the incident, information was conveyed to MEO Saleem Sharif, who immediately visited Akshara School. During the inspection, locked rooms within the school premises were opened, and notebooks and textbooks worth several lakhs of rupees were reportedly found stored in a designated room. The rooms were subsequently sealed by the authorities.

Student union leaders also questioned how permission had been granted for a school

to operate in a building that had previously housed a bar and restaurant. The MEO reportedly stated that strict action would be taken against private schools found selling books without proper authorization.

Education System Has Become a Rejection Machine Says Congress Leader K. Prashanth Reddy

Alleges failure in central exam system; praises Telangana's education reforms under Revanth Reddy Government

Narayanpet : District Congress Committee President K. Prashanth Reddy has sharply criticized the current education system in India, calling it a rejection system rather than one that nurtures student talent. Speaking at a press conference held at CVR Bhavan in Narayanpet district headquarters on Wednesday, he alleged that the system is failing to recognize students' abilities and instead filters out the vast majority of aspirants.

He said Congress leader Rahul Gandhi has been engaging in nationwide interactions with students, youth, and parents, highlighting the urgent need for structural reforms in education. According to him, the present framework is flawed because only a very small percentage of students secure opportunities while the rest are labeled as failures.

Citing national level competitive exams, Prashanth Reddy pointed out that



nearly 23 lakh students appear for NEET, around 13 lakh for JEE, approximately 25 lakh for UPSC, and crores for Railway Recruitment Board examinations every year. He argued that despite massive financial and academic preparation, the central government has failed to ensure fairness and confidence among students.

He further stated that in IIT entrance examinations, only about 30 students are selected out of nearly 3,000 candidates in a given context, leaving the vast majority without opportunities. Similarly, lakhs of medical aspirants

appearing for NEET are left without seats, which he said reflects systemic limitation rather than a true measure of merit.

Referring to the NEET paper leak controversy, he termed it evidence of administrative failure in the national examination system. He criticized the National Testing Agency (NTA) for its handling of examinations and demanded accountability from the Union Education Minister, even calling for resignation on moral grounds. He also expressed concern over repeated exam irregularities causing severe mental stress

among students, with some reportedly driven to extreme steps.

Shifting focus to Telangana, he praised the state government led by Chief Minister Revanth Reddy, stating that it is taking historic steps to transform education. He said the government aims to provide quality education irrespective of caste, religion, or economic background through the establishment of integrated residential schools equipped with modern science labs, digital classrooms, libraries, and sports facilities.

He added that the government is working to elevate public education to corporate standards, ensuring access for children from poor and middle class families. Special attention, he said, is being given to backward regions like Narayanpet, alongside major irrigation initiatives aimed at transforming the Narayanpet Kodangal region.

While the BJP government is turning students into examination machines, the

Congress party is fighting to fulfill students' dreams. If the Modi government is leading towards destruction, the Revanth Reddy government is moving towards development, he stated.

He announced that the party will soon hold special meetings to understand students' opinions, issues, and suggestions, and convey them to state and national leadership. He urged students not to lose hope and to move forward with confidence.

Strict Action Against Encroachments and Illegal Pattas on Government Lands: Collector Koya Sriharsha

PEDDAPALLI BUREAU : Peddapalli District Collector Koya Sriharsha on Wednesday stated that the district administration is giving utmost priority to safeguarding public assets and will initiate stringent legal action against land encroachments, illegal pattas (land titles), and revenue fraud. Following his directives, revenue authorities conducted a comprehensive inquiry into forged land titles in Potharam and Maidambanda villages of Mutharam mandal.

The investigation—which involved verifying revenue records and conducting field inspections—confirmed that 19 acres and 01 gunta in Survey No. 59 of Potharam, along with 11 acres and 02 guntas in Survey No. 113 of Maidambanda, are absolute government properties.

The inquiry established that the claimants had never cultivated or physically possessed these lands. Consequently, the Collector ordered the immediate cancellation of the illegal pattas, and the 30-plus acres of land have been successfully re-



claimed under the official government account.

Taking a serious view of the fraud, Collector Koya Sriharsha ordered strict legal and disciplinary action against the illegal occupants as well as the outsourced government personnel who colluded to forge the titles.

The implicated staff include Gujjula Sridhar (Helper, Mission Bhagiratha, Manthani Sub-division), Padala Satish (Data Entry Operator, MPDO Office, Manthani-Mutharam), and Dhoomala Shrivani (MGNREGA Field Assistant, Mutharam). The Collector emphasized that prosecution will be pursued rigorously under relevant laws.

Repairs Must Be Carried Out to the Government School: Munigela Ramesh

SFI and DYFI demanded that district education authorities take immediate action against the institution for what they described as arbitrary fee collection and misleading promotional practices. Anti-Corruption Bureau (ACB) to investigate alleged irregularities and financial practices within the institution. They further criticized the government and education department officials for allegedly supporting the expansion of corporate educational institutions. Action Plan Needed for Disposal of Praja Palana Applications : Special Officer N. Sreedhar

Sreedhar, directed officials to prepare a special action plan for resolving applications received during the 99-day Praja Palana Pragathi Programme. A review meeting with officials of various departments was held at the IDOC office on Wednesday to assess the programme conducted between March 6 and June 12. On the occasion, District Collector Rahul Sharma explained the activities undertaken by different departments through a PowerPoint presentation. Speaking at the meeting, the Special Officer said that out of 6,391 applications received in Gram Sabhas, 716 had been resolved, and the remaining applications should be addressed on a priority basis. He noted that a large number of applications were related to pensions, double-bedroom houses, electricity, roads, and drinking water facilities. He instructed officials to ensure effective sanitation, waste management, plantation drives, and maintenance of streetlights in villages and urban areas. He also emphasized increasing student enrolment in government schools and ensuring quality food and education in



welfare hostels. District Collector Rahul Sharma stated that a time-bound action plan was being prepared to address the issues raised under the Praja Palana programme. District SP Sankeerth said that extensive awareness programmes on road safety, drug abuse prevention, and the protection of women and children were conducted during Gram Sabhas. District Forest Officer Naveen Reddy, Additional Collectors Ashok Kumar and Vijayalakshmi, along with district officials from various departments, attended the meeting.

RCS Demands Crop Loans, Quality Seeds and Protection for Tenant Farmers

Mulugu, Bhupalpally, June 24 : The Rythu Coolie Sangham (RCS) has urged the government to waive existing crop loans and sanction fresh crop loans to farmers for the upcoming agricultural season. In a representation submitted to the district administration, the organisation highlighted the difficulties being faced by farmers due to inadequate rainfall and rising cultivation costs. The union stated that many farmers had already sown cotton and chilli crops over large areas, but the delay in monsoon rains has resulted in significant financial losses. It demanded that quality seeds, fertilizers, agricultural implements and pesticides be supplied to farmers at subsidised rates to support cultivation activities. Expressing concern over fertilizer availability, RCS pointed out that farmers faced severe hardships during the previous Kharif season, with long queues reported at Primary Agricultural Cooperative Societies for urea supplies. The organisation urged the State Government to ensure that urea produced at the Ramagundam Fertilizers and Chemicals Limited



(RFCL) plant first meets Telangana's requirements before being diverted to other states. The farmers' body also raised alarm over the increasing circulation of spurious seeds and pesticides in the market. It noted that poor-quality agricultural inputs have led to crop failures, mounting debts and, in some cases, farmer suicides. The union called for stringent action against fake seed companies and those involved in black marketing of fertilizers and agricultural chemicals. RCS further demanded that fresh crop loans be extended to all eligible farmers and that fertilizers, seeds, pesticides and farm equipment be distributed

through cooperative societies to ensure transparency and timely availability. The organisation also sought implementation of the rights guaranteed under the Tenant Farmers Act and the issuance of identity cards to tenant farmers. Rythu Coolie Sangham demanded immediate government intervention to address these issues and safeguard the interests of the farming community. Joint Warangal district convener, Mandala Ugandhar, other leaders Ambarish, Alladi Venkanna, Narender, Boya Rajanna, Gopu Rajanna, Naliganti, Paul, Biskula Manjula were present on the occasion.
